● Electrical Characteristic Curves

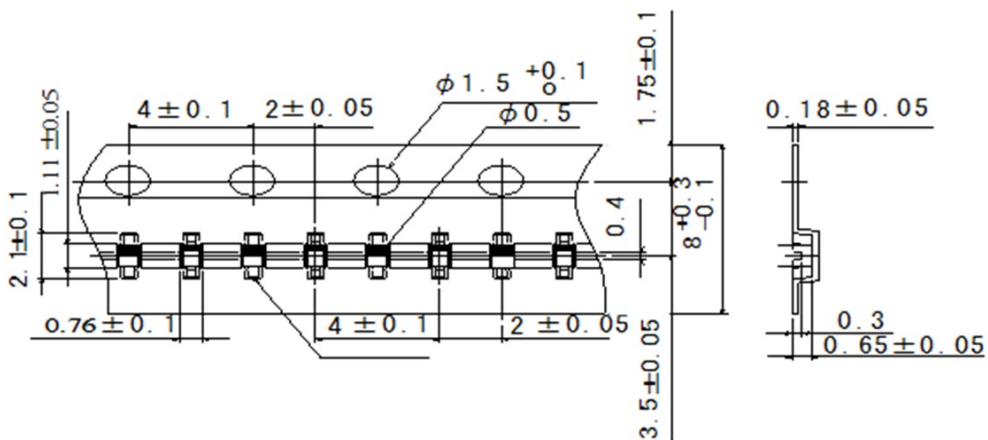
